



#### **Decision No. 2**

New Tariff Concessions and the Establishment of two sub-committees for the Joint Committee of the Agreement on Economic Cooperation between the Government of the Republic of China (Taiwan) and the Government of the Kingdom of Eswatini

The Agreement on Economic Cooperation between the Government of the Republic of China (Taiwan) and the Government of the Kingdom of Eswatini (hereafter referred to as the "Agreement") was signed in June 2018.

The 1st Meeting of the Joint Committee of the Agreement was held on the 29th of September 2021.

#### **DECISIONS:**

In accordance with the Functions and Rules of Procedure of the Joint Committee of the Agreement; the following decisions were made:

# 1. New Tariff Concessions

- 1.1 The Joint Committee agreed on the provision of new tariff concessions for 27 product lines by the Republic of China (Taiwan). This translates to a further removal of obstacles to trade as per subparagraph (d) of paragraph 3 of Article 14 of the Agreement and Article 1.2d of Decision No.1 of the Joint Committee (see Annex: List of Concessions Made by the Republic of China (Taiwan))
- 1.2 The two parties agreed to continue to facilitate regular communication and consultations.

### 2. The Establishment of two sub-committees

- 2.1 The Joint Committee agreed to establish two sub-committees in accordance with Article 1.3a of Decision No.1 of the Joint Committee in accordance with Article 14 of the Agreement.
  - a) The Trade and Investment Sub-Committee and the Legal Affairs Sub-Committee.
  - b) The composition and the terms of reference for the two sub-committees are yet to be developed.
