



Decision No. 3

The New Tariff Concessions under the Agreement on Economic Cooperation between the Government of the Republic of China (Taiwan) and the Government of the Kingdom of Eswatini

The Agreement on Economic Cooperation between the Government of the Republic of China (Taiwan) and the Government of the Kingdom of Eswatini (hereafter referred to as the "Agreement") was signed on June 2018.

The 2nd Meeting of the Joint Committee on the Agreement was held on 24th August 2022.

DECISION(S):

In accordance with the Functions and Rules of Procedure of the Joint Committee of the Agreement, the following decision(s) was made:

The New Tariff Concessions

The Joint Committee agreed on the provision of new tariff concessions for 21 product lines by the Republic of China (Taiwan). This translates to a further removal of obstacles to trade in accordance with Article 14 (3) (d) of the Agreement, and Article 1 (2) (d) of Decision No.1 of the Joint Committee (see Annex: List of Concessions Made by the Republic of China (Taiwan)). The two parties agreed to continue to facilitate regular communication and consultations.

The Decision is signed in duplicate in the Chinese and English languages, with both texts being equally authentic.

The Decision shall enter into force thirty (30) days after the Republic of China (Taiwan) and the Kingdom of Eswatini have notified each other of the completion of the necessary internal legal procedures.
